Transfer from Associate to Corporate membership fees to be submitted with application (about \$2000)

Refer to aiyc.net/resources, click on standing resolutions for the current membership dues, initiation fee and one share of Club Stock, plus all applicable Wisconsin sales tax. Checks are cashed after the board has voted on the new membership. As long as the application is completed and the funds are correct, the "Date Received" on the bottom of this application will be the date your seniority begins. Make your check payable to Apostle Islands Yacht Club. Associate members do not need to pay a second membership payment if their membership dues are current.
